IBCSOMS 2016 Certifying examinations Bangalore, India

The International Board for the Certification of Specialists in Oral and Maxillofacial Surgery (IBCSOMS) continues to move forward with credentialing, examining and certifying qualified oral and maxillofacial surgeons who meet the standards established that address the needs of the public and speciality internationally.

To date, the IBCSOMS has conducted three certifying examinations in OSAKA, Japan and BANGALORE, India. The first examinations were held in March 2015 and 47 Japanese candidates participated. The most recent examination was held in Bangalore, India and participants included candidates from India, China, UAE, Nepal, South Korea and The United States. The IBCSOMS certification examinations are indeed becoming international events. There were 42 successful candidates in Bangalore examination and the convocation was held in ICOMS 2017 at Hongkong in April this year. Dr. (Col) Madan Oration: MIDCOMS 2017, CHANDIGARH

The respect and honor of a person remains even after he is gone and that is because his legacy remains. One such legacy is that of Dr. (Col) Sushil Kumar Madan who was not only a prominent Oral and Maxillofacial Surgeon but also a full ranked Colonel in the Indian Army. Dr. (Col) Madan was well recognized in the field of maxillofacial surgery both in India and overseas. He was a registered Oral Surgeon in India, England and Australia. Pioneering the art of Obwegyee's Intra-Oral Sagittal Split Osteotomy of the mandible in India, he was the first to present his work at the All India Plastic Surgeon Conference in 1973 and received huge accolades. His resonance with Paulson's approach of the TMT and his work on Orbital protrusion has been widely published and recognised. In his memory and to pay tribute to his contribution to the field of Oral and Maxillofacial Surgery we have been organizing the Dr. (Col) Madan Oration every year during the mid-term conference. To deliver this oration we choose one of the prominent members and an accomplished Maxillofacial surgeon from our association.

This year, to grace this oration, we have invited one of the most dynamic surgeons in our fraternity to bestow us with his knowledge and experience. **Dr. Rajesh Dhirwani** is a man of great repute and his work and contribution to the field of maxillofacial surgery is of top quality.



Dr. Dhirwani after completing his BSc and BDS in 1975 and 1979 respectively, completed his post graduation in Oral and Maxillofacial Surgery in 1982 from Bombay University and secured an hon. grad. receiving the prestigious Dr. Dinkar Award for best performance in this field. To achieve greater heights and to improve his surgical skills Dr. Dhirwani went on to do a fellowship in maxillofacial surgery at the University of Maryland, Baltimore, USA. He also went ahead to learn the nuances of Implantology in Ernst Charles Weiss Implant Centre in West Germany. Prof. Dhirwani's pursuit of being one of the most proficiently trained surgeons took him to other units in Scotland, Austria, Hongkong etc. to name a few. He is one of the pioneers in the field of Oro-Facial Laser application in India.

Dr. Dhirwani is currently the professor and director of Maxillofacial Surgery, L. J. Jee and is the director and chief Maxillofacial surgeon of one of the busiest units in Jalandhar – Jalandhar Hospital and research centre.

Dr. Dhirwani's scientific achievements is an exhaustive list and this being a recipient of the Rajendra Prasad is well recognised among the many laurels bestowed on him. He is a Diplomate of Indian Board of Maxillofacial surgery and the International Academy of Osteointegration. He is also the recipient of the prestigious Nene Panchard Academy fellowship and the professional excellence award in academic research category from B. K. S. Foundation.

Dr. Rajesh Dhirwani has published his work in various international and national followed journals and has also presented them at conferences worldwide. He has been an invited speaker in many national and international conferences to share his experience in our field. His contributions to the association have been phenomenal over the years and he held the position of the AOMSI president in the year 2001-2002.

It is an honour and privilege to have him here to deliver the Dr. (Col) Madan Oration as one of the most accomplished oral and maxillofacial surgeons in our country.

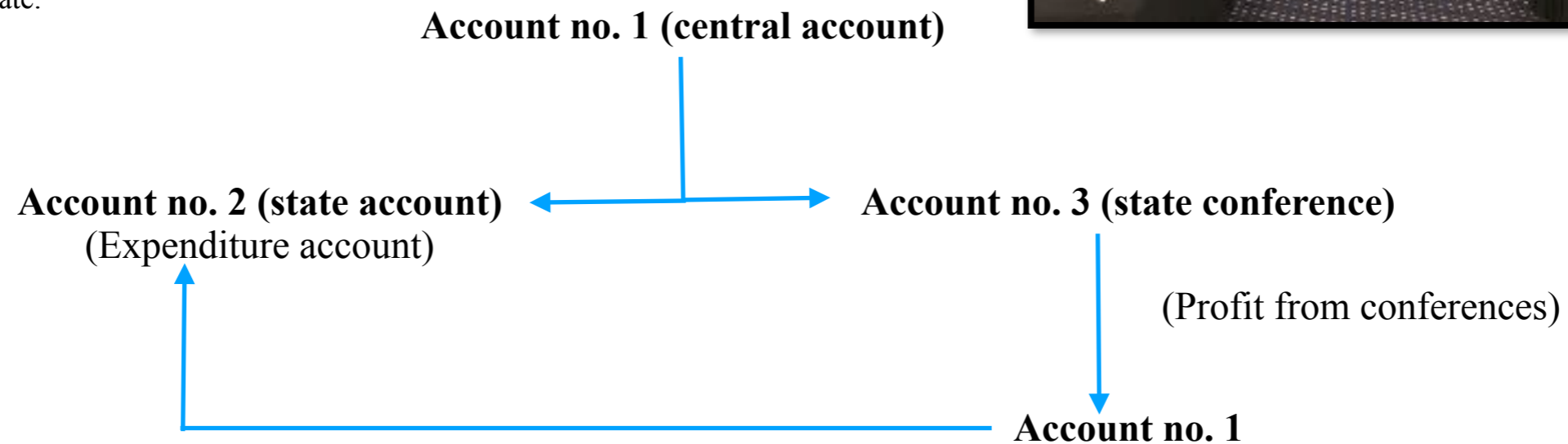


STATE SECRETARIES MEETING

Journal (JMOS)

EDITOR'S REPORT – 2017

At the outset I would like to thank all the previous editors whose hard work has brought our journal to be among the best in specialty journals worldwide. I took over as the new editor of JMOS after being duly elected to the post at the national conference of AOMSI at Ahmedabad in November 2016. There was seamless transition of the editorial management software of Springer (publisher of JMOS) from the previous team to the new editorial board. Three new associate editors were included as were some more high quality reviewers. In pursuit of our objective to improve the impact factor of the journal, two new sections were introduced in the journal, namely “Submissions to perspectives” and “Mini review” (a) Submissions to perspective: Perspective articles represent succinct opinion pieces that address various topics of relevance to oral-maxillofacial surgeons. These topics may include, for example, public policy, patient safety, health care or surgical trends, government actions, and commentaries on other subjects. (b) Mini review: Mini reviews will cover the whole remit of the specialty & will provide up-to-date knowledge by a recognised expert in the field and are by invitation only. Word limits for the existing articles were also reset in line with the best practices followed in scientific journal publishing, so as to accommodate a larger number of articles in any one issue. A new Facebook page was introduced for the journal, highlighting the journal's activities and engaging the readership, which has been very well received. Total number of articles submitted to JMOS till August 2017 : 265 which is line with previous year's figures .We are hoping to report highest ever submissions at the end of 2017. Total number of full text downloads till July 2017 : 20825 (corresponding figures for 2015: 14169 & for 2016 : 20095). Total Royalty for JMOS paid by Springer to AOMSI in June 2017 : 1526184/- which is more than the royalty in any previous year which did not have any supplemental issue publications.

It has been decided to give away three JMOS best article prizes from the National conference in Nagpur onwards .This is a step towards encouraging authors and also making our journal the first preferred destination in scientific publishing in the specialty world over. Three issues of the journal have been published in 2017. Each issue was published in the first week of the first month of the quarterly cycle for the respective issue. Early online publication is believed to lead to higher download rates, thereby positively impacting the revenues as well as the impact factor of the journal. For ease of online access to the electronic version of the journal SMS's were sent to the members with details of their user name and passwords.

We continue to move forward as a motivated team of efficient editors and dedicated reviewers .The goal is to strive for newer heights for the JMOS in the coming years.

TREASURER REPORT

Though the treasurer took over the office following the Ahmedabad national conference in November 2016, due to official procedural delays involving transfer of branch and change of signatories, actual functioning from the new office started only by march, 2017. This can be attributed to the official bureaucracy inherently associated with nationalised banks. I believe it underlines the case for transferring the account to a scheduled bank that would provide a better and personalised service. (Kotak Mahindra / HDFC / ICICI etc)

Currently we still function with a savings bank account which is against RBI guidelines for an association / society, and the bank officials have advised to maintain status quo till a directive comes to change the present system. Eventually we need to move to a current account that follows guidelines. A scheduled bank will ensure easier transfer of branch following change of office bearers; provide personal assistants for the treasurer and secretary (including cheque pick up / cash delivery etc) and also interest on the cash in current account.

Scheduled banks also have better internet banking services with multiple approval transfers for jointly held current accounts like ours, which will bring in better transparency in functioning.

The financial transactions of the association and duty of treasurer has increased many fold in the previous few years owing to the new activities that are being conducted by the association including fellowships, master classes, fellowship exams, gatherings in addition to the EC meetings, and so on. Moving on we should look forward to availing better banking services to ease the duties of office bearers who put in extra effort to ensure the smooth functioning of the association.

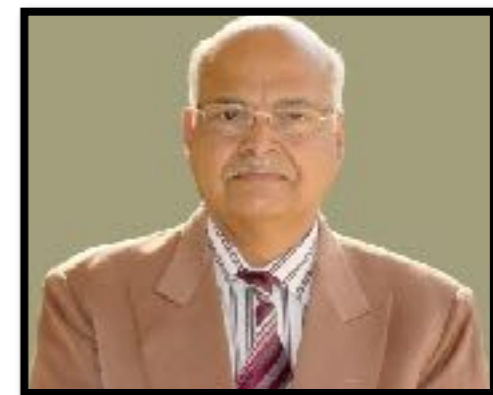

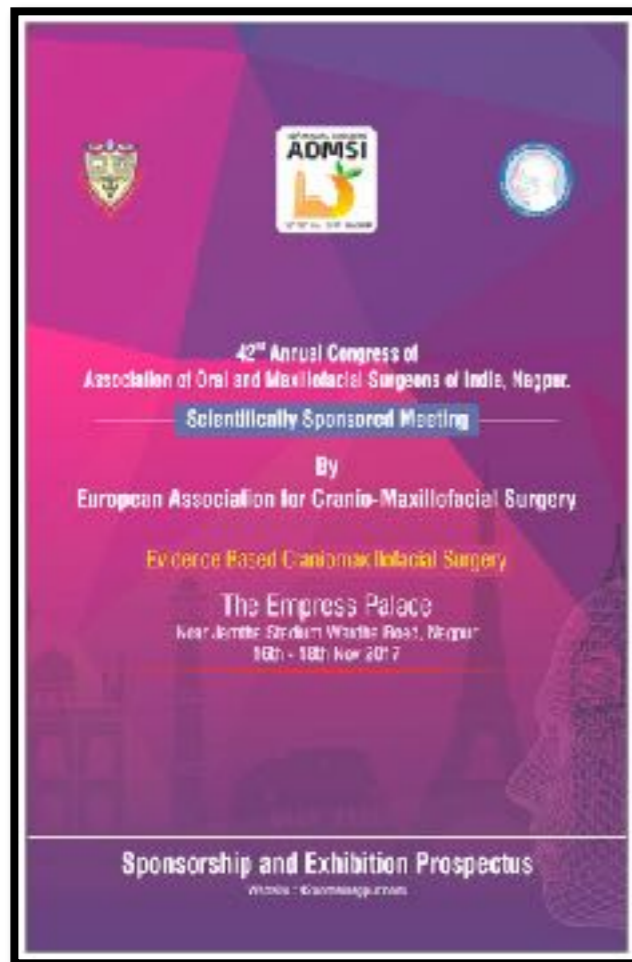
