# SPOTLIGHT INTERVIEW

**Dr. Dushyant Prasad**

Dr. Dushyant Prasad is a healthcare and non-profit professional, who founded ABMSS in the year 2015. He is the General Secretary and Executive Director of ABMSS, an organisation that helps in funding surgeries free of cost for cleft lip and palate to the less privileged sections of our society. In addition to this, the organization focuses on comprehensive care for a cleft child; awareness activities for malnutrition; immune system regeneration for weaker sections and medical knowledge advancement for professionals supporting NGOs.

Dr Dushyant has spent around 15 years in developing cleft care and set up programmes in South East Asia, while he served as the International programmes advisor for Deutsche Cleft Kinderhilfe eV., an international charity that works around the world.

He was also the former CEO of Inga Health Foundation. While he was the regional director South Asia for Deutsche Cleft Kinderhilfe e.V., he initiated strategic partnerships with Smile Train in Vietnam and Operation Smile in The Philippines.

Most recently, he has been instrumental in setting up the American arm of ABMSS in Wisconsin, USA.

In the year 2019 the Partnership/MoU with ABMSS was signed between AOMSI & ABMSS for funding fellowship program, From 2023 has added their 1 ABMSS centre cleft fellowship program at Agra into AOMSI apart from the existing 4 fellowship program.

The partnership with ABMSS has made it possible for AOMSI to provide more opportunities for young Maxillofacial surgeons to gain valuable experience in their chosen fields, while contributing to the betterment of society.

Dr. Dushyant has been the driving force in supporting Cleft fellowship programs by joining hands with AOMSI also. In this section we will throw spotlight on the work of ABMSS , and their dynamic founder.

## Spotlight Interview

**First of all thank you for your contributions to cleft training and for taking out time for this interview sir. Let us start the beginning- how was the idea of ABMSS and specifically cleft care conceived?**

I have been associated with cleft care organizations for over 15 years. I have been the former CEO of Inga Health Foundation and was the Regional Director and International Programmes Advisor for Deutsche Cleft Kinderhilfe for close to a decade. While working at Deutsche Cleft, I set up many projects in India and South East Asia. In 2015, I launched the Cleft India initiative of ABMSS with the thought process that ABMSS will concentrate only on one problem and work on that in the more holistic manner. The idea of ABMSS was to create the only indigenous cleft charity that raises funds in India and abroad and provides care locally but think globally and to create a delivery mechanism for cleft care.



**ABMSS is different from other NGOs as it not only provides funds but also streamlines various facets of cleft care and thus works in tangible degrees to improvise the outcome. Can you elaborate upon the process?**

ABMSS is a nationwide charity with a focus on cleft care operating since 2015. The core philosophy at ABMSS is that no cleft child remains untreated and must be provided safe

and quality care. The work at ABMSS is broadly divided into four main programmes-

**Gifting Smiles:** Free cleft lip & palate surgeries at over 36 hospital locations. In addition, 6 full fledged comprehensive cleft care centres that offer the entire spectrum of cleft care free of charge.

**Skill Drill:** A programme to exchange knowledge among surgeons and other medical professionals and provide upskilling workshops for the latest nuances in cleft care.

**SafeT in the OT:** to advocate and ensure safe surgery by providing capacity building in terms of operating theatre infrastructure.

**ClefTech:** enhancing innovation and employing low cost tech driven medical systems and equipment to help improve delivery of care.



**In these many years of your experience in ABMSS- which moment/ memory is most remarkably etched (any anecdote / experience)**

I have some times bumped into patients operated under our project once in a store while shopping, another time a gardener in an IT company when I had gone for a meeting and the greatest joy is they being happy for the surgery they received from ABMSS without knowing who I was.



### What traits you deem essential for a successful cleft surgeon ?

The first quality is being a leader, skill sets is of course an hygiene factor. More importantly, a cleft surgeon should be both passionate towards the discipline and compassionate towards the patient.



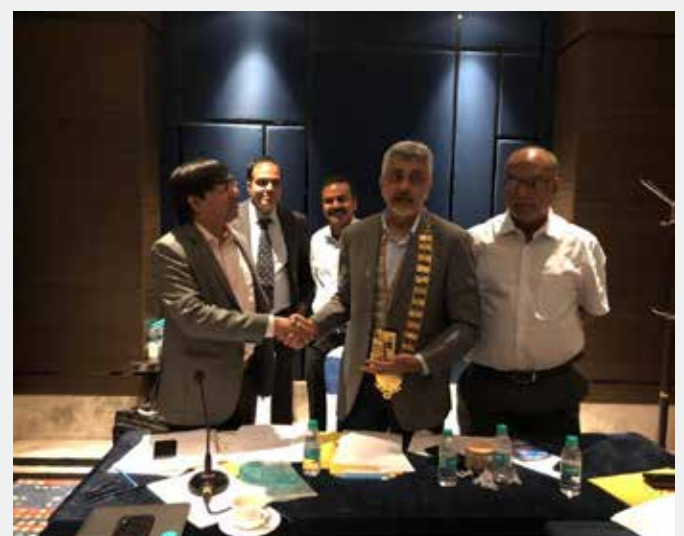
### How do you perceive the growth of the association between ABMSS and AOMSI?

I am glad we embarked on this partnership. In 2014, I had given a talk at the AOMSI national conference to enthuse young surgeons to get into cleft work. Since then we have come a long way with a formal partnership in 2019. I am hopeful that this collaboration shall scale as our key resources are the maxillofacial surgeons and as the second largest cleft charity in India we do have an arena of opportunity for many at the AOMSI.



### Any message for our younger surgeons who wish to join the cleft surgical squad?

As I said earlier, passion and compassion must be there. After that, it's a very infectious journey. The tangible result in carving a smile that was hidden in a face is the most memorable aspect for any surgeon. It gives purpose to your profession.

My association with the fellowship committee started from 2019, Initially involved with the interview process, feedback of fellows, Conducting online fellowship exams at various centers across country. In the year 2022 was appointed as chairman for the fellowship committee for 2yr period. The fellowship committee was earlier headed by Dr. Krishnamurthy Bonanthaya, Dr. Vvivek Vardan Reddy and later by Dr. Ramadas

In the year 2019 the Partnership/MoU with ABMSS was signed between AOMSI & ABMSS for funding fellowship program, From 2023 has added their 1 ABMSS centre cleft fellowship program at Agra into AOMSI apart from the existing 4 fellowship program.

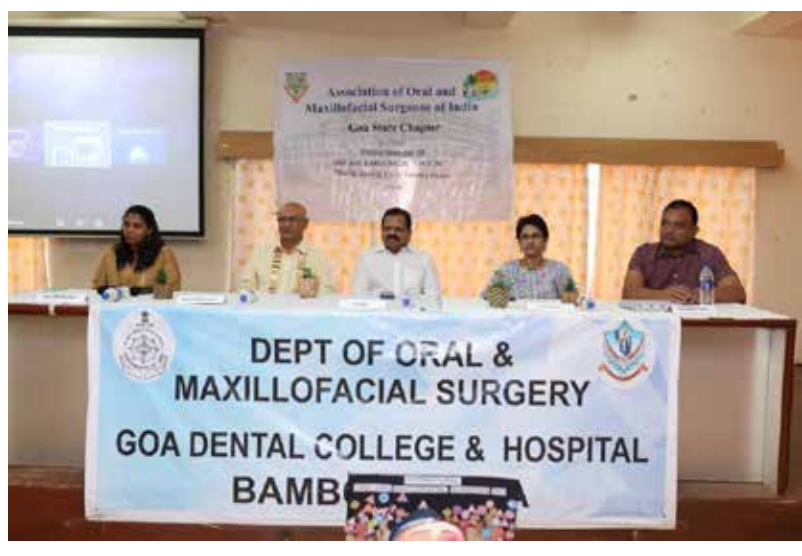

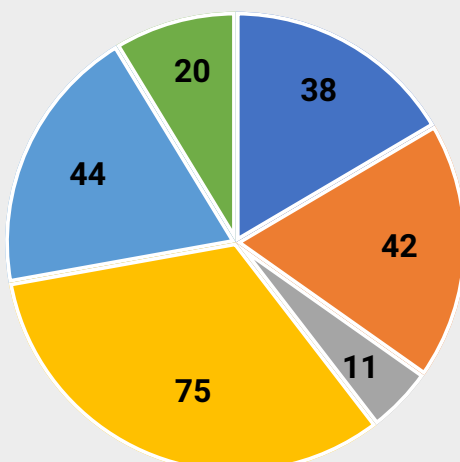

## What makes this centre special ?

1. Concept-based teaching for management of cleft and craniofacial deformities
2. Acquiring skills for primary management of patients with Traumatic injuries
3. Meticulous planning of dentofacial deformities on 3-D articulator and on virtual platform with diligent on-table execution.
4. Multidisciplinary management and collaboration with other in-house specialists for treatment of concomitant injuries such as ENT, Ophthalmology, neurosurgery, orthopaedics etc.
5. Comprehensive management of a cleft child from its primary deformities to complete rehabilitation into adolescence.
6. Thorough assessment of the outcomes achieved post-operatively to analyse the execution of the planned treatment.
7. Elaborate discussion on diagnosis and treatment planning of all cases to be operated with particular emphasis on management of surgical complications.
8. Distinct focus on maintaining standardised clinical and radiographic records.

1. Describe in one word your time at the fellowship centre ?  
Comprehensive

2. Your learning experience at the centre ?

An exhaustive centre for learning the nuances of maxillofacial surgery, with particular emphasis on the concepts and principles of surgery. The centre is an unprecedented centre for diagnosis and management of facial deformities with specific attention towards thorough assessment, detailed planning, surgical technique, accurate execution, and complete post-op care. Besides, the centre also offers an excellent chance to learn the basics of surgical orthodontics due to the presence of an in-house orthodontist.

Apart from being an excellent centre for learning orthognathic surgery, the centre offers an opportunity to explore other fields in craniomaxillofacial surgery such as facial traumatology including primary management in the ER, comprehensive management of Cleft and related craniofacial deformities, diagnosis and management of temporomandibular joint disorders, Oral tumours, management of maxillofacial space infections etc.

3. Briefly describe a typical day at the fellowship centre ?

The day usually started at 08:00 am with the ward rounds at my centre as well as the other associated hospitals where we operate. The surgery in the morning at our medical college usually commences at 9.30am. It is followed by clinical OPD, which is from 2pm-5pm wherein we examine the new out-patients and evaluate the follow-up patients. We also have valuable discussions on possible treatment strategies and optimal outcomes for the patient. The OPD hours are followed by evening surgeries in the city from 5.30pm,





which go on till late depending on the case. Simultaneously, any calls from the ERs of these hospitals are attended to and any minor procedures, if any, are performed in the minor OT.

#### **4. Any particular anecdote which you would like to share with us ?**

There have been many enduring moments with Dr. Mustafa that would stay with me as lifelong memories. Be it the banter in the OT, his obsession for vintage rock music, his facetious exchanges with our orthodontists or his nonchalant guise on (very) occasional delays. But the pinnacle of them all was when our centre won the Ginwalla Trophy for the best scientific paper in the Indore AOMSI national conference 2022. His enthusiasm and obsession to win the coveted trophy was unparalleled and rubbed onto us. Sir is thrifty with acclaims but the sheer elation and contentment in his eyes, after we won the trophy and knowing that I contributed to that, in my own miniature way was something I'd always cherish.

#### **5. What did you learn beyond OMFS ?**

Fellowship programmes isn't just about learning the subject. It taught me the significance of working as a team, being modest enough to call for help whenever required and importance of effective communication in patient management. Above all, our loyalty must always be with the patient and thus quality must triumph over quantity at all times.

#### **6. How did the fellowship program help you ?**

The purview of maxillofacial surgery is immense and the process of learning is ceaseless. Besides the plethora of knowledge and concepts I picked up during my tenure, the program also enabled me to hone my surgical skills. It has taught me the importance of thorough planning and meticulous execution with patient-centric treatment planning.

#### **7. Your advice to the young OMF surgeons ?**

My advice to all young surgeons like me would be to have confidence in what you can achieve. Be sincere and constant in your efforts to be the best possible version of yourself.

Also don't demarcate between "what I should know" and "this is not required for me to know." Consume all possible knowledge that comes your way as no learning is ever squandered.

Attention to detail is a cardinal aspect of learning that distinguishes the good from the best. Thus we must aim at meticulous work rather than brisk work.

Lastly, focus must always be on what can be learnt in the centre rather than what cannot be. As needless focus on what's missing obscures our ability to perceive what's actually present.

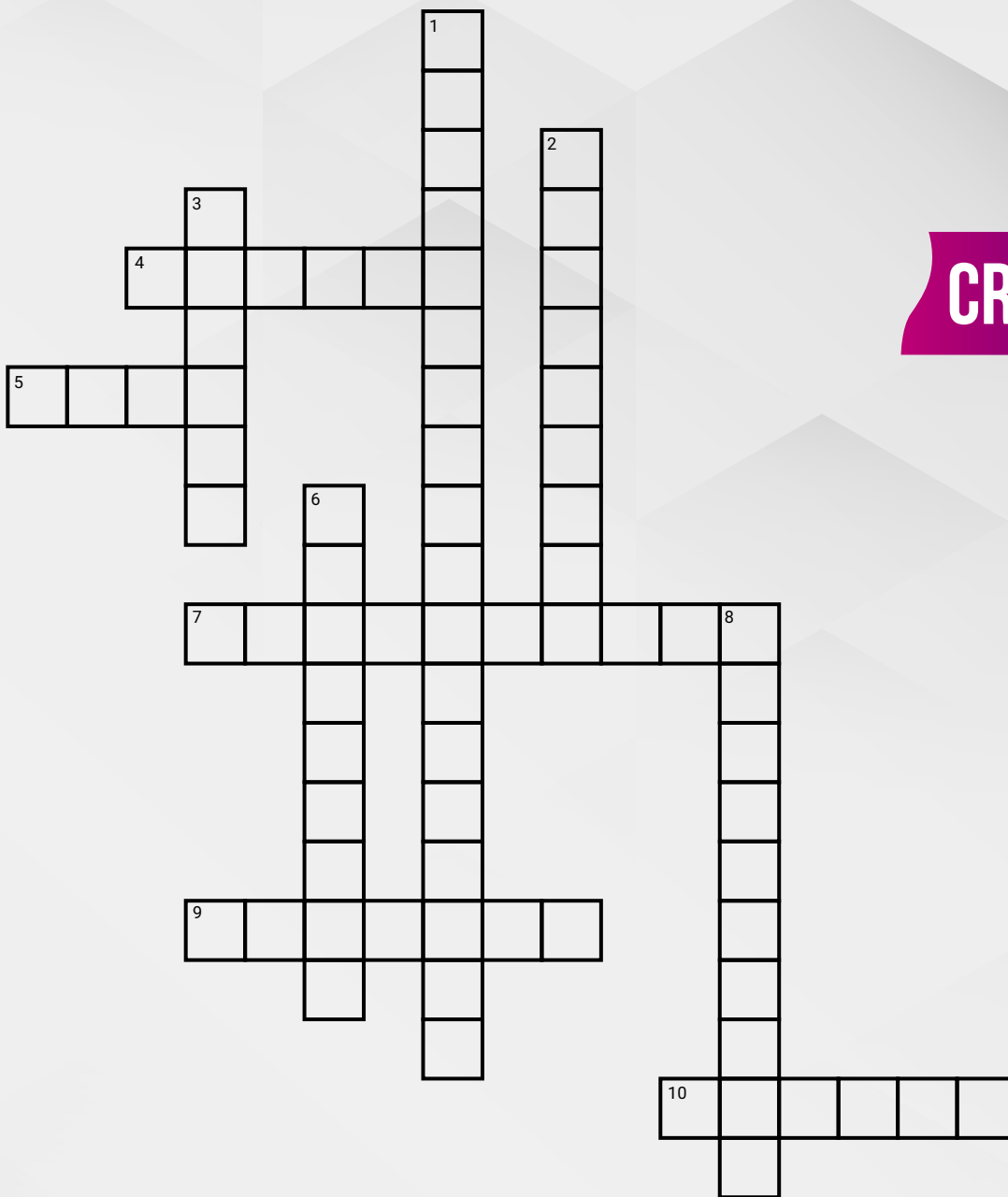

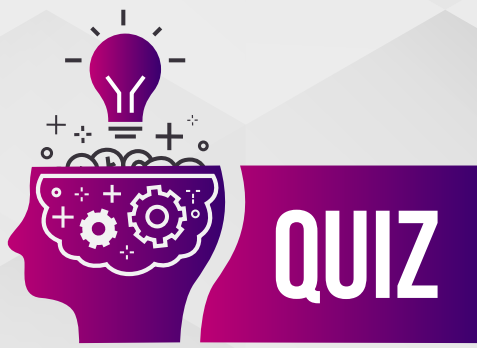

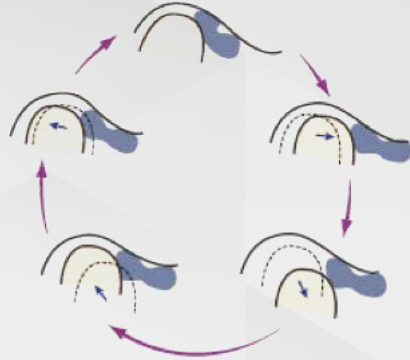
