

**Association of Oral And Maxillofacial Surgery**  
**Minutes of AGM**  
**22<sup>nd</sup> November, 2013 KIIT University Bhubaneswar, Orissa**

The 38<sup>th</sup> Annual General Body meeting of AOMSI started at 10.00 AM in the Board room of the conference venue.

Hon. Gen. Secretary, Dr. Manjunath Rai collared the President, Dr. Neelam Andrade Noel.

Dr. Neelam Andrade, briefly welcomed the office bearers, contestants of the election and the other members who had gathered.

## **Any other Matter:**

### **◆ Regarding training for undergraduates:**

Senior member, Dr. Pradip Ghosh requested the association to take active role in education with DCI and understand the need for strengthening the curriculum for undergraduates and post graduates. AOMSI EC members informed that the members of the educational committee are taking care of this matter.

Dr. Anurag from Lucknow and other few members felt that lot of Medico legal cases are on the rise and wanted to know what role Association can play in protecting interest of member. After a discussion, it was decided that new formed EC will introduce a Legal cell who will help in solving these kinds of matters. It was also decided that AOMSI Head office should conduct more of workshop / CME on these Medico legal cases in the Mid-term / Annual Conferences.

### **◆ Fellowship programme:**

Dr. George Paul suggested the EC that post MDS fellowship should be started in some of subspecialty of Oral Surgery like Maxillo facial Trauma and Orthognatic surgery. It was decided to form a committee who will come out with guidelines to start the fellowship programmes in different centres.

### **◆ Regarding non members paper/ poster presentation:**

It was decided in AGM, non members of AOMSI can only attend the conference by paying the higher fee than that of members of AOMSI. It was unanimously decided that only the members of AOMSI will have the privilege of presenting paper / poster / chair a scientific session and deliver a guest lecture in student category / delegate category in all the AOMSI Conferences.

### **◆ Conference Guidelines:**

Dr. Rishi Bali briefed that in AOMSI conferences, proper guidelines are not followed. It was decided to come up with new guidelines for AOMSI conferences.

Dr. Manjunath Rai thanked the President and all the EC members for supporting and helping him in running the Association smoothly in last three years. He also thanked all members for electing him for one more term and seek their co-operation and support for the second term.
